ELECTRONIC MEETING INFORMATION & INSTRUCTIONS

Pursuant to Executive Order #2020-154, issued by Governor Gretchen Whitmer on July 30, 2020, the Board of Trustee meeting on **Tuesday, October 20, 2020 at 7:00 pm** will take place electronically due to health concerns associated with COVID-19. Although some stay home restrictions have been lifted, Executive Order 2020-183 still prohibits indoor public gatherings larger than 20 people per 1,000 square feet.

Members of the public may access the agenda materials via the Township website – www.whitelaketwp.com by end of day, **Thursday, October 15, 2020**, but possibly sooner.

Members of the public wishing to participate in the electronic meeting may do so by:

Please note, when calling in by telephone the caller's phone number will be visible in the public meeting. As an option, most telephone companies have a feature to make phone numbers private by dialing *67. If you have this feature and wish to block your number, press *67 before dialing the meeting call-in number.

Procedure for public comment by electronic means:

Under Executive Order 2020-154, there must be full opportunity for both the general public and the members of the Township board to hear and be heard at appropriate times during the meeting. Public participants will be muted upon entry to the meeting, but will have a chance to speak during public comment.

Once connected to the meeting, members of the public wishing to participate in the virtual public comment must alert us that they wish to speak by pressing *9 on their telephone keypad. Pressing *9 will activate the “raise hand” feature signaling to us that you wish to comment. Because of limitations with muting and unmuting members of the public, there will only be one public comment period which will be announced by the Township Supervisor or meeting moderator at the appropriate time. If a public hearing is involved, members of the public will be allowed to speak. The Supervisor will announce when the hearing is open to the public and call on residents as outlined in the following paragraph.

Participants will be called on one at a time, as would happen during an in-person meeting. When you are unmuted, please introduce yourself by stating your name and address for the record. You will then have (3) minutes to share your comments with the Township board. At the conclusion of your comments or your (3) minutes, you will be muted and removed from the public comment queue.

Participants may also choose to submit written comments that will be read into record during public comment by the Supervisor. Submit any written comments via e-mail to PPergament@whitelaketwp.com by Noon, **October 19, 2020**, the day before the meeting.

Procedures by which persons may contact members of the Township board prior to the meeting:
