Pursuant to Executive Order #2020-154, issued by Governor Gretchen Whitmer on July 30, 2020, the Board of Trustee meeting on **Thursday, August 18, 2020 at 7:00 pm** will take place electronically due to health concerns associated with COVID-19. Although some stay home restrictions have been lifted, Executive Order 2020-160 still prohibits indoor public gatherings larger than 10 people.

Members of the public may access the agenda materials via the Township website – [www.whitelaketwp.com](http://www.whitelaketwp.com) by end of day, **Thursday, August 13, 2020**, but possibly sooner.

#### Procedure for public comment by electronic means:

Under Executive Order 2020-154, there must be full opportunity for both the general public and the members of the Township board to hear and be heard at appropriate times during the meeting. Public participants will be muted upon entry to the meeting, but will have a chance to speak during public comment.

**Once connected to the meeting, members of the public wishing to participate in the virtual public comment must alert us that they wish to speak by pressing \*9 on their telephone keypad.** Pressing \*9 will activate the “raise hand” feature signaling to us that you wish to comment. Because of limitations with muting and unmuting members of the public, there will only be one public comment period which will be announced by the Township Supervisor or meeting moderator at the appropriate time.

Participants will be called on one at a time, as would happen during an in-person meeting. When you are unmuted, please introduce yourself by stating your name and address for the record. You will then have (3) minutes to share your comments with the Township board. At the conclusion of your comments or your (3) minutes, you will be muted and removed from the public comment queue.

Participants may also choose to submit written comments that will be read into record during public comment by the Supervisor. Submit any written comments via e-mail to [PPergament@whitelaketwp.com](mailto:PPergament@whitelaketwp.com) by **Noon, August 17, 2020**, the day before the meeting.

#### Procedures by which persons may contact members of the Township board prior to the meeting:
