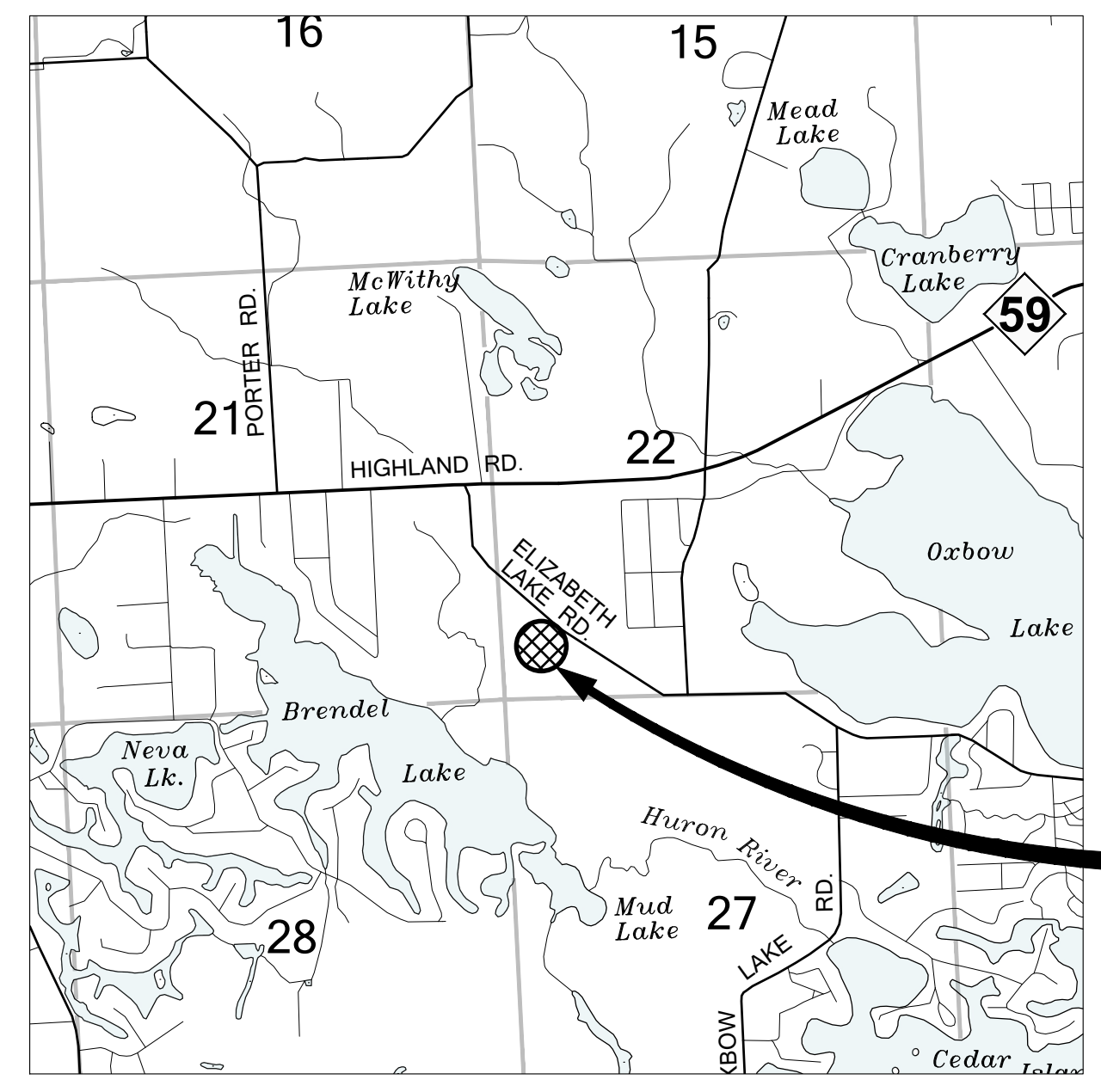
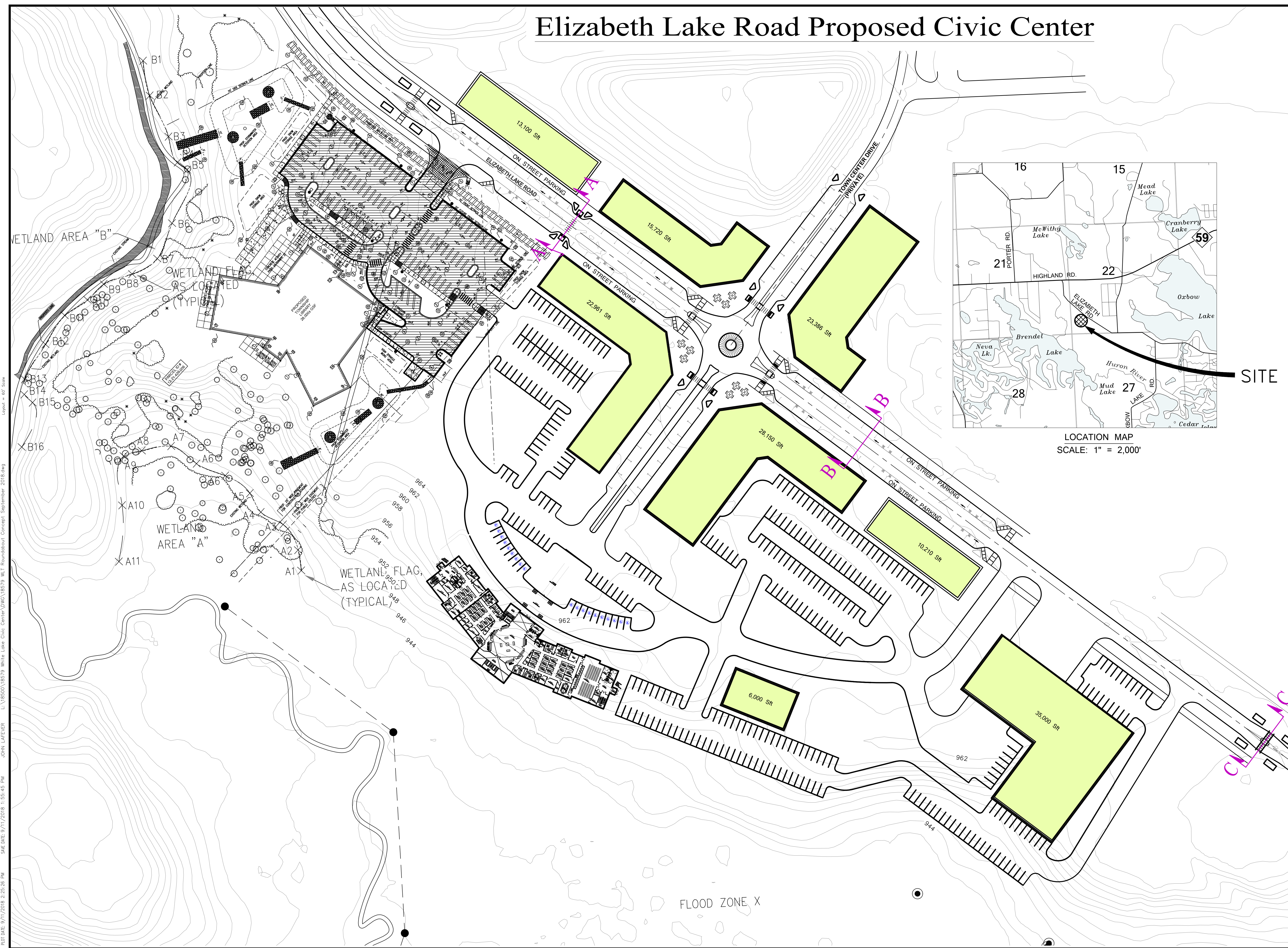


Elizabeth Lake Road Proposed Civic Center



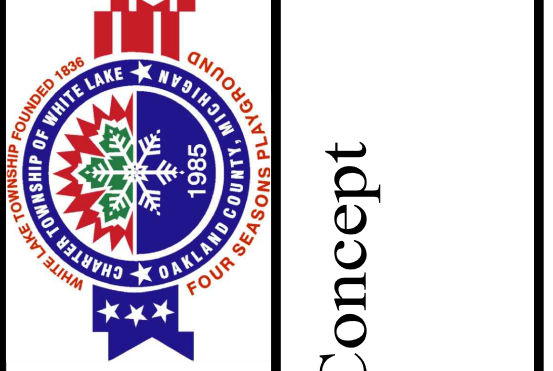
LOCATION MAP
